Board of Directors Meeting April 17, 2023

# **Open Meeting**

Cindy Sterling called the meeting to order at 9:00 a.m.

## Secretary's Report

There were no changes or additions to the Board of Directors Meeting of March 2023. The minutes were accepted as distributed.

## **Treasurer's Report**

# **March Financials**

Peggy Puckett reported that the General Checking Account balance was \$7363.19 and was reconciled with UMB as of March 31, 2023. Included in that balance are deposits for \$120.00 and a withdrawal of 3,536.00 for GHIN membership.

The Tournament Checking Account balance was \$10.929.57 and has been reconciled with UMB statement as of March 31, 2023. There was no activity in the month of March.

Sue Galinski was absent from the meeting; she is vacationing in Florida.

## **Director of Golf**

Craig Pullen was absent as he was finally able to get his vacation scheduled and taken.

#### **Committee Chair Reports**

**Rules** – Gabie Bull mentioned that there was a concern about standing over the hole when putting she will investigate the concern.

Additionally, there is confusion about the red and green stakes. Green tops mean the area is an Environmentally Sensitive Area (ESA). See insert below:

# ENVIRONMENTALLY SENSITIVE AREAS

• The ESA's are marked as lateral water hazards with red stakes that have green tops.

- · These areas are federally-protected and golf cart and foot traffic is prohibited in these areas.
- $\cdot$  Balls are NOT to be retrieved from or played out of any ESA.

 $\cdot$  If a ball is inside the hazard markers, the golfer shall proceed under penalty of one stroke, using the applicable rule for a lateral water hazard.

 $\cdot$  If a ball is outside the hazard markers but the ESA interferes with the area of the golfer's intended stance or swing, relief may be taken with no penalty. Get your stance and then one club length, no closer to the hole.

If a ball goes into the red staked area, the ball can be played out of the staked area, or take ball out incur a 1 stroke penalty, 2 club lengths, or Go back as far as you like keeping point of entry and flag in line.

On play days only (not major tournaments), on holes where the ESA crosses the fairway (Holes 2 South, 3 West, 4 West and 9 West) and it is questionable as to whether your shot has gone into the ESA or cleared the ESA, another ball may be played without abandoning ball #1.

If ball #1 is in fact playable, ball #2 would be picked up and NO penalty would be incurred.

If ball #2 is played, all penalties with RULE #26 Lateral Hazard Rule will apply.

#### **Tuesday Play Day**

There are 44 players signed up for our next playday. Lunch is still being finalized.

#### **Tournament Chair**

Linda Scott reported that all tournaments are proceeding very well.

## Handicap

Jamey Siefert raised a question on the handicap requirements for the Hoof N Heels tournament. Linda Scott and Cindy Sterling shared what has been used in the past i.e., GHIN listings and home course provided data. Jamie also reported that the silver and red combination tees are ready in Golf Genius, but the scorecards have to be updated. Cindy mentioned the possibility of having a playday where everyone plays the combination. Jackie Williams requested that everyone when posting a birdie, chip-in etc. that they post on the same day when possible and include the date.

#### Social

The feedback on the luncheons have been favorable on both food and price. It was requested that a reminder be in the minutes that they do not have to play to go to the luncheon they just have to notify the Social Chair or playday member and pay.
